WHEREAS, the Board has reviewed the Petition and all relevant information related thereto; and

WHEREAS, the Board of the District desires to grant the Petition and approve the inclusion of the Property into the District.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD AS FOLLOWS:

1. <u>Grant of Petition</u>. The Board hereby grants the Petition and orders the inclusion of the Property into the District.

- 2. <u>Effective Date of Resolution</u>. This Resolution shall become effective as of the date hereof.
- 3. <u>Motion and Order for Inclusion</u>. The Board hereby directs its legal counsel to file a motion with the District Court in and for El Paso County seeking an Order for Inclusion.
