A regular meeting of the Board of Directors of the Cascade Fire Protection District was held on Monday, November 14, 2022, at 7:00 PM, at Cascade Fire Station, 8015 Severy Road, Cascade, CO, and via video teleconference. The meeting was open to the public.

- 1. Call to Order: President Whittemore called the meeting to order at 7:02 PM.
- 2. Declaration of Quorum/Director Qualifications/Reaffirmation of Disclosures: President Whittemore confirmed a quorum was present.
